UPON COMPLETION OF ALL EVALUATION AND SCORING, THE EVALUATION COMMITTEE UNANIMOUSLY AGREED TO INVITE THE TOP FOUR (4) RANKED PROPOSERS OF BOTH LOTS 1 & 2 TO NEGOTIATION MEETINGS. THE COMMITTEE RECONVENED ON JUNE 7, 2017, THE COMMITTEE MET WITH EACH SHORTLISTED PROPOSER FINALISTS. THE COMMITTEE WAS PRESENTED WITH A BRIEF PRESENTATION FOLLOWED BY QUESTION AND ANSWER SESSIONS BY EACH FINALISTS. ON JUNE 20, 2017, THE EVALUATION COMMITTEE RECONVENED IN A PUBLIC EVALUATION COMMITTEE MEETING WHEREBY THEY RANKED THE FOUR FINALISTS FOR LOTS 1 & 2. UPON COMPLETION OF THE RANKING, THE COMMITTEE UNANIMOUSLY AGREED TO INVITE THE TOP TWO (2) RANKED PROPOSERS OF BOTH LOTS 1 & 2 TO ADDITIONAL NEGOTIATION MEETINGS. THE TOP TWO (2) RANKED FINALISTS INCLUDED THE FOLLOWING:

ON JULY 10, 2017, THE COMMITTEE RECONVENED AND CONTINUED WITH NEGOTIATIONS WITH THE TOP TWO RANKED PROPOSERS FOR LOTS 1 & 2. UPON COMPLETION OF ALL NEGOTIATION MEETINGS THE EVALUATION COMMITTEE HELD A PUBLIC EVALUATION COMMITTEE MEETING WHEREBY THEY PROVIDED THEIR FINAL RECOMMENDATION OF AWARD FOR LOTS 1 & 2 OF ITN-2017-RM1-6.

THE EVALUATION COMMITTEE REACHED CONCENSUS AND UNANIMOUSLY AGREED TO RECOMMEND AWARD TO CITY NATIONAL BANK FOR BOTH LOTS 1 & 2.
